I, on my own behalf and on behalf of my child(ren), further agree to defend and indemnify the Parties Released from and against any and all liabilities, claims, actions, damages, costs, or expenses of any kind arising out of or relating to any loss, damage, injury, or death, that may be sustained by me, or my child(ren) related to COVID-19 while participating in any program offered to COVID-19 while participating in any program form and against any and all liabilities, claims, actions, damages, costs, or expenses of any kind arising out of or relating to any loss, damage, injury, or death, that may be sustained by me, or my child(ren) related to COVID-19 while participating in any program offered by Changing Expectations.
